

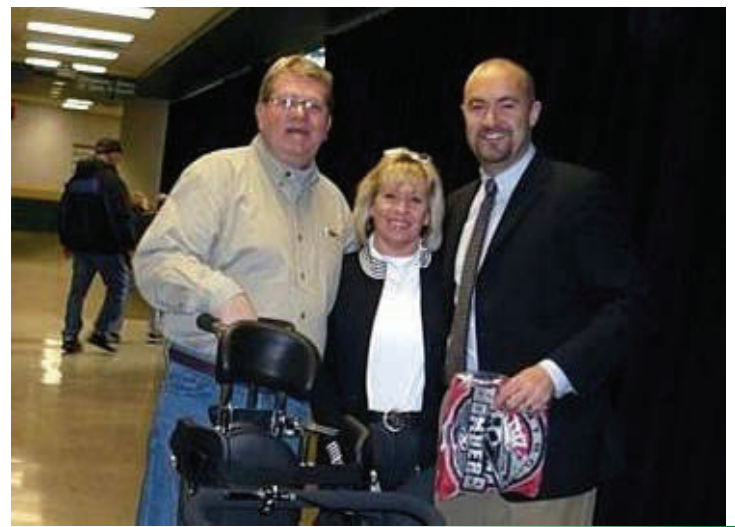
## Reynolds & Reynolds Sponsors AmTryke

Reynolds & Reynolds recently sponsored a family evening at a Dayton Bombers game. They sold 2500 tickets (almost 8000 people were in attendance at the game) and as an added activity they raised enough money to sponsor the donation of an AmTryke.

Costa Papista, co-owner of the Bombers Hockey Organization, suggested Greenebucs when Reynolds & Reynolds was looking for a charitable project.

In a highlight of the night, Reynolds associates helped present a specially equipped, customized bike to Nick Langer, an 11-year-old Kettering youngster with severe Cerebral Palsy. He and his family were Reynolds' special guests at the game. Reynolds associates raised money for the bicycle through a raffle at headquarters. Overall, associates raised more than \$800 for the purchase of the bike and a donation to the AmTrykes program.

Nick and his family were presented with the bike during a pre-game ceremony held rink-side. According to Nick's mom, this is his first bike and it gives him the opportunity to "ride a bike equally with his three brothers," she explained. Nick, who is a big sports fan, also got to shake hands with several of the hockey players. Nicholas, the oldest of 4 brothers, has always wanted a bike so he could ride with his brothers.
